

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document.

Q1. Which of the following best expresses your view of the proposed Bill?

My experience of end of life over the years has led to my wish for individuals to have help in ending their suffering with dignity in their own country. With sufficient safeguards, assisted dying would remove the fear of a painful, undignified death our Australian and New Zealand citizens have. The choice of assisted dying being available to me would give me peace of mind as I get older.

Safeguards must be in place to prevent individual 'choice' through coercion, whether intended or not.
