

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document.

Questions marked with an asterisk (*) require an answer.

All responses must include a name and contact details. If you do not include a name and/or contact details, we may have to disregard your response.

Q1. Which of the following best expresses your view of the proposed Bill?

A person's life belongs to them and them alone, and if they wish to end it in dignity no one else should have the right to deny them.

Q2. Do you think legislation is required, or are there other ways in which the Bill's aims could be achieved more effectively? Please explain the reasons for your response.

Legislation is the most straightforward way. Otherwise the decision might come down to the arbitrary opinions of individual doctors etc.

Q3. Which of the following best expresses your view of the proposed process for assisted dying as set out at section 3.1 in the consultation document (Step 1 - Declaration, Step 2 - Reflection period, Step 3 - Prescribing/delivering)?

Please explain the reasons for your response, including if you think there should be any additional measures, or if any of the existing proposed measures should be removed. In particular, we are keen to hear views on Step 2 - Reflection period, and the length of time that is most appropriate.

The current proposal seems sensible to me. A reflection period is probably appropriate, even though a person declaring their wish for assisted suicide has undoubtedly thought about it a great deal prior to the declaration.

Q4. Which of the following best expresses your views of the safeguards proposed in section 1.1 of the consultation document?

Please explain the reasons for your response.

I agree with all of the safeguards except for the one saying that the patient has to administer the medication themselves. What if they are mentally able to make and communicate their choice but physically unable to carry it out? That seems like a disadvantage for those patients who might actually need this new legislation the most because their quality of life is possibly the lowest.

Q5. Which of the following best expresses your view of a body being responsible for reporting and collecting data?

Please explain the reasons for your response, including whether you think this should be a new or existing body (and if so, which body) and what data you think should be collected.

I don't have enough legal knowledge to foresee circumstances where data collection might be necessary. If it was me or my relative, I would probably see an assisted death as a highly personal matter and not a matter of statistics, but I suppose there is no tangible harm in collecting the data either.

Q6. Please provide comment on how a conscientious objection (or other avenue to ensure voluntary participation by healthcare professionals) might best be facilitated.

First all relevant healthcare professionals should be educated about the exact ins and outs of the assisted death process so that their decision to participate or not is exactly as informed as the patients'. Then a model similar to the new organ donation legislation might be appropriate; assumed consent but with an easy way for individuals to object.
