

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document.

Anchoring the bill on the base of strong scientific evidence is imperative in order to make it safe and credible and trustworthy.

General

Q10. Do you have any other additional comments or suggestions on the proposed Bill (which have not already been covered in any of your responses to earlier questions)?

A step to be kept in the back of our minds should be to stop confining the right to define one's life and death to the terminally ill. Terminally ill means having some kind of physical illness that is terminal. There are mental and psychological illnesses that can darken lives and make them unbearable just as much as physical ones. These illnesses are just as real as the physical ones, and people afflicted with them ought to have the same rights as people with terminal physical illnesses.

Education, supervision and accompaniment/guidance/psycho-hygiene of the people who actually guide individuals wishing to die and their families through the whole process must be an issue, and any laws regulating the issue must be formulated with utmost clearness in order to safeguard both personnel and clients.
