

# Assisted Dying for Terminally Ill Adults (Scotland) Bill

## Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document.

Questions marked with an asterisk (\*) require an answer.

All responses must include a name and contact details. Q1. Which of the following best expresses your view of the proposed Bill?

## General

Q10. Do you have any other additional comments or suggestions on the proposed Bill (which have not already been covered in any of your responses to earlier questions)?

I have had a member of my family starved to death following the Liverpool care plan. It is inhumane to put people through this suffering against their wishes and we would not treat animals like this. I should not be put into the situation where I would consider taking my life early for fear that I would be incapacitated and not have the ability to prevent a life of prolonged and unnecessary suffering. The option of peacefully ending your life when you are terminally ill should not be the preserve of the wealthy who can travel abroad whilst I would consider taking my life early and alone to protect my wishes and family members. Individuals should have the right to determine how their lives end if they are terminally ill and not be forced to have their pain and suffering dragged out based on others religious or moral objections.
