

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. Q1. Which of the following best expresses your view of the proposed Bill?

Fully supportive

It is high time legislation reflected what the polls have been showing consistently for years - overwhelming public support for assisted dying. For too long the majority has been blocked by religious leaders and politicians anxious of backlash from a small minority.

It is essential. This has to be placed in law. It will protect the medical profession and anything less will be thwarted and evaded by the actions of pressure groups and nervous professionals.
