

# Assisted Dying for Terminally Ill Adults (Scotland) Bill

## Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. There are currently no means to help vulnerable people from committing suicide if they are being pressured by others, this not only puts in place a comprehensive system for the provision of legal and safe assisted dying but also provides a way to identify vulnerable people in such circumstances and provide help for them, that currently is not positively provided or in any meaningful way available.

My view is that this should be standard health care and I do recognise any ethical premise for clinicians having supportable objection. The right to die must not be frustrated by superstition, mythology or similar personal belief.
