

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document.

I think that people should have the right to be helped to end their own lives if that is what they want. All life comes to an end at some point and it seems unfair to force someone to prolong a life which they think is not worth living.

Yes, legislation is required in order to provide clarity about what is acceptable and to protect those who may help someone to die.

Partially supportive

Please explain the reasons for your response, including if you think there should be any additional measures, or if any of the existing proposed measures should be removed. In particular, we are keen to hear views on Step 2 - Reflection period, and the length of time that is most appropriate.

The reflective period seems to be about right but it should indeed be much shorter for those with only a few days to live. In extreme cases, 24 hours would be enough.

The reason that I have put "Partially supportive" is that I am worried about people who are too weak or incapacitated to take the medication themselves. I think that it should be permissible for a HCP to administer the medication as long as the person indicates clearly that they are ready. This will not be needed often but may be needed, for example, in cases of Motor Neuron Disease where the person is clearly wishing to be helped to die but does not have the physical ability to take the medicine themselves.

Many of the likely objections to this bill will come from faith-based organisations. People of faith do not need to worry about this bill since it has sufficient safeguards to protect them. They do not need to avail themselves of an assisted death. However, I strongly object to having my freedom to decide my own fate being restricted by people of a faith which I do not share nor believe in.
