

# Assisted Dying for Terminally Ill Adults (Scotland) Bill

## Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. I am unfamiliar with the bodies responsible for similar situations, but I do think that data should be collected about how many people make the choice, what sort of situations the choice is made in. I also believe that we should have some independent advisory service to avoid bias when a person is trying to make the decision. Support for family and friends may also be required. I would support a family member's choice to take this decision, but not everyone would and this end of life rift would be really hard for people.

Q6. Please provide comment on how a conscientious objection (or other avenue to ensure voluntary participation by healthcare professionals) might best be facilitated.

Since the person must administer the medication themselves, the healthcare professionals should have the option on whether to be present or not and whether they wish to have a part in this. However, I honestly believe that by working in healthcare, these professionals make choices about patient care anyway, and this is really just an extension to caring for a person.

I think this will reduce costs as it will require less long term palliative care facilities and hospital stays by allowing the person to make an exit from the world rather than prolong their suffering. PTSD from watching someone suffer horrendously and then die would already require therapy so the loss of a person before they suffer may actually affect people less! Probably the one thing where costs will be incurred would be for an advisory team for patients who are considering the process and the actual cost of the medication for the patient, however these costs will be lower than a long hospital stay and life preserving medication.
