

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document.

Q1. Which of the following best expresses your view of the proposed Bill?

Fully opposed

Please explain the reasons for your response.

Proposals indicate that some lives are not considered to be as 'valuable' as others. Also, believe this would undermine the trust that I, and others, would have in doctors.

No. Greater investment in care for the elderly and palliative care would be my preferred approach to ensure that last stages of life are supported appropriately without I view as the THREAT of assisted dying.

Fully opposed

My view on the sanctity of life and that doctors should not assume a divine role (ie on when someone should die) mean I am completely opposed to this.

Q4. Which of the following best expresses your views of the safeguards proposed in section 1.1 of the consultation document?

Fully opposed

Please explain the reasons for your response.

Supposed safeguards implemented in other countries have gradually been eroded and my fear would be that the same would happen here. Also, very concerned that the elderly and terminally ill would believe themselves to be a burden and feel forced to comply with legal pressure to agree to assisted dying.

Q5. Which of the following best expresses your view of a body being responsible for reporting and collecting data?

Fully opposed

There should be no need for this to be done as this Bill should not become law.

Very concerned about this as the history of such protections, arising from conscientious objections, is not encouraging. Eg when Sunday trading started shopworkers were told they would not be penalised if they opted out. In practice this is no longer the case. Similarly for medics, regarding supporting/authorising abortion, or teachers advising pregnant school girls without the need to inform their parents.
