

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. I think it is a well researched Bill which will clarify the position and allow access of all to a well managed and chosen end to life. I hope it will lead to a less stressful death for both the person and their family. Also hope it will lead to more openness in discussing death and allow improvements in access and delivery of palliative care

Legislation is required so all parties involved are clear on where they stand. It is happening in an unregulated way at present which is not in the best interest of anyone involved.

Think reflection period is reasonable and good that there is aim for some flexibility when death is considered more imminent. I would hope that once established most people could have this discussion and make the request earlier on in their illness. I would like some clarification as to who is considered as an appropriate HCP. More clarity needed about how prescription would be triggered. As there is a requirement for administration to be watched and recorded there could be logistical problems organising this. Was interested in fact that 15% of those registered in Oregon did not use the prescription- assuming that meant that they never requested it be dispensed.
