

# Assisted Dying for Terminally Ill Adults (Scotland) Bill

## Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document.

Q1. Which of the following best expresses your view of the proposed Bill?

Fully opposed

**Please explain the reasons for your response.**

I believe that your proposal, although well-intentioned, sets up a false dichotomy between dying in unbearable pain and being gently assisted out of life. With proper palliative care, no one should die in agony. Assisted dying puts an unacceptable pressure on medical staff and also on people who may feel themselves to be a burden. Many tightly controlled assisted dying bills have been widened with the result that people never envisaged in original bills have been killed. Rather, much more effort should be put into campaigning so excellent palliative care is accessible for all who need it.

Q2. Do you think legislation is required, or are there other ways in which the Bill's aims could be achieved more effectively? Please explain the reasons for your response.

I do not think legislation is required to bring in assisted dying but legislation may be required to bring in proper resources for palliative care
