

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document.

All responses must include a name and contact details. Obviously if the person in question is terminally ill then the required time for 'Step 2 - Reflection period' should be commensurable to the amount of time that they have been given to live, thus preventing further pain and suffering.

I would have chosen 'Fully supportive' but for the 1.1 Safeguard that 'the person should administer the life-ending medication themselves'. What if the person is physically unable to administer the life-ending medication themselves but still wishes to end their life? There should be a clause for people with disabilities.

Q6. Please provide comment on how a conscientious objection (or other avenue to ensure voluntary participation by healthcare professionals) might best be facilitated.

If a healthcare professional conscientiously objects to Assisted Dying for Terminally Ill Adults, then they have made their choice and can object by giving their views to this consultation. Beyond this, they should have no say whatsoever over the rights of a terminally ill adult wishing to die. Period.

Financial Implications

The National Health Service (NHS) is point of entry service for everyone. Therefore if a terminally ill adult presents themselves and wishes to die, they should be allowed to do so and facilitated in their decision. Health professionals working within the NHS should already be available to facilitate the needs of the public. Funding of the NHS should be returned to the same levels that is was before the 'banking crisis' (pre-2008). The subsequent political motivation and ideological imposition of austerity was and continues to be categorically wrong. Normalisation of austerity is only cost effective for the profits of the ruling class and the corporations they serve. No one should profit from another persons choice to die.

Equalities
