

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document.

Q1. Which of the following best expresses your view of the proposed Bill?

Please explain the reasons for your response.

Having witnessed first hand the torture that is suffered by the terminally ill as they are 'allowed to die' over several weeks, I conclude that we would prosecute anyone who 'allowed' an animal to be treated in this way. Therefore, it should be within the power of the individual to choose to die if they do not wish to suffer or to have the mental agony of the slow death. The hypocrisy of making humans suffer , whilst prosecuting those who make animals suffer, is extraordinary.

I do not feel qualified to answer, I just know that nearly everyone I discuss this issue with does want the individual to be given choice as to how and when they end their lives, without fear that those who helped them might be prosecuted for this. The medical profession must be given the ability to help those who ask for it.
