

# Assisted Dying for Terminally Ill Adults (Scotland) Bill

## Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. Q1. Which of the following best expresses your view of the proposed Bill?

**Please explain the reasons for your response.**

The time is right for an assisted dying law. Having had relatives die in needless pain and suffering, there has to be a better way. We treat our animals better than we do our fellow humans. Suffering often is far greater than medicine/palliative care can alleviate - and to what end? So some people among us can impose their opinions on others? Terminally ill people currently have few options - die alone in Switzerland (if you can afford it and are able to travel); refuse food and water to starve/dehydrate to death over days; commit suicide behind closed doors which can put family members at risk of prosecution? This is about choice at the point of life where no other options are available. Please support this consultation and introduce an assisted dying bill to the Scottish Parliament.
