

# Assisted Dying for Terminally Ill Adults (Scotland) Bill

## Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document.

Questions marked with an asterisk (\*) require an answer.

All responses must include a name and contact details. Q1. Which of the following best expresses your view of the proposed Bill?

Fully supportive

Data needs to be collected to raise visibility of the sorts of conditions that some find they would rather avoid via Assisted Dying. At least then that might prevent people reaching that fork in the road by means of better targeted investment in research.

Q6. Please provide comment on how a conscientious objection (or other avenue to ensure voluntary participation by healthcare professionals) might best be facilitated.

If Assisted Dying is made lawful there should not be a means for a health professional to dodge their responsibility to the individual via conscientious objection.
