

# Assisted Dying for Terminally Ill Adults (Scotland) Bill

## Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document.

A civilised society should not be providing terminally patients with legal drugs .This would change the culture of dying in this country and the way in which Scottish vulnerable people will be viewed.Supposedly this is to prevent a painful death when in fact as been proved assisted suicide is neither painless or peaceful. Nor is it dignified. More support for palliative care for those with a terminal illness is the solution.
