

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document.

Please explain the reasons for your response.

I support assisted dying for mentally competent terminally ill patients because watching a loved one die a painful and drawn-out death seems inhumane if they would rather choose to end their life when they choose. This would give terminally ill patients the option to control when they die at a time when nothing else is really in their control and all they can see before them is pain and suffering. My grandmother died after a long battle with cancer and what caused her a great deal of distress was that her grandchildren

would remember her as the bed-ridden cancer patient, rather than the wonderful grandma she was. She hated us seeing her in pain and debilitated by the disease.
At the moment, if a terminally patient would like to choose when they die, their only option is to go abroad, to a clinic in Switzerland for example. This means they do not get to be at home when they die and cannot choose this option at all unless they have enough money to do so, making it a privilege of the rich.
Surely it is now time to provide terminally ill patients with the option to die with dignity at home at a time of their choosing, giving them control over this final choice at a time when they can control little else about their health, body and prognosis.

Q2. Do you think legislation is required, or are there other ways in which the Bill's aims could be achieved more effectively? Please explain the reasons for your response.

I think legislation is required to ensure that terminally ill patients are not exploited, ie assisted to die when this is not what they want, or refused this option by medical practitioners who may not agree with it.
Assisted dying should be legalised, but there have to be procedures and processes involved to make sure that it is carried out in the correct manner to guarantee those that choose this option the dignity and compassion they deserve in death.
