

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. The officers of the Pagan Federation (Scotland) discussed the issue of 'Assisted Dying for Terminally Ill Adults' at their full council meeting on Sunday 10th October 2021 and then agreed to take part in 'Dignity in Dying's' letter writing campaign. SPF's council members have since agreed to respond to Liam's proposed Bill in a likewise manner. All council members have their individual reasons for supporting assisted dying which range from personal experience of working as health care professionals with terminally ill people, to watching loved ones suffer before dying, to concern for themselves knowing the likely pathway of their own medical conditions.
