

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document.

Definitely need to legalise Assisted Dying but obviously with strict control.
If my father had been given the option he would definitely have taken, what he asked for, a 'blue pill' - he was of sound mind and, perhaps sadly, understood too well what was happening to him.
His death left a huge void in our family which is to be expected but the way he died will haunt me forever.
