

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document.

All responses must include a name and contact details. Q1. Which of the following best expresses your view of the proposed Bill?

Fully supportive

Please explain the reasons for your response.

There do need to be safeguards, which are proposed, but perhaps do not go far enough. There has to be no doubt that anyone has been coerced into asking for assisted dying. Doctors must be unbiased, whatever their own beliefs. This goes for everyone involved in the process, and has to be checked.

Q5. Which of the following best expresses your view of a body being responsible for reporting and collecting data?

Fully supportive

This will give unbiased statistics on the use of assisted dying. This is important to check it is working properly, and to be able to see what might need to be changed in the future.

Q6. Please provide comment on how a conscientious objection (or other avenue to ensure voluntary participation by healthcare professionals) might best be facilitated.

Doctors should not be forced to assist dying if they have a strong belief it is wrong for them. That would not be good for anyone, and would alienate doctors.

A survey of doctors should be carried out to assess their views, so there is an indication of how many would object. Further steps can be taken once this is known
