

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. Please explain the reasons for your response.

As a man of 86, and having a low tolerance of pain, I live in fear of a long painful illness. I see death as simply the end of life, a stage we all have to pass through, and I have no religious belief about what follows. We now have developed skills in palliative care and in analgesics, that make it totally unnecessary for a person at the natural end of life to be kept alive in pain or distress, when they wish to let go of life.. I do not see that the law should reflect the religious beliefs of a minority of the people.

I believe legislation is needed, to remove legal penalty from either the patient or anyone helping them, but this is not enough. We need to help the medical professions come to accept that helping someone die, who wishes it, is indeed helping, and is fully within the bounds of ethical practice.
