

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. Yes, I think legislation is required as it would set out clearly what is acceptable, who is responsible and how the decisions can be made. This can then ensure that no one feels undue pressure, whether that is medical professionals, those that are considering assisted death, family or friends.
