

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. I would have thought it likely to lower the public cost long term. Using my father for example, he had 6 months in a care home facility which would not have been required had he been able to end his own life when he chose. This cost around £30,000. I would be surprised if the cost for administering assisted dying per individual would be that much.
