

# Assisted Dying for Terminally Ill Adults (Scotland) Bill

## Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. ## General

Decision makers need to know that at ground level..the people who really matter..are the chronically/terminally ill and their families. Do not assume that there are hospices, Macmillan nurses ,nursing homes or hospital beds for all. My husband had none of that and died at home after years of me stressful trying to manage his care. The support was nowhere near adequate..and I fought beyond belief for every bit of what was provided. Day and night I did his meds food, water through a peg into his stomach. I suctioned him day and night. I gave him oxygen day and night. I was given the bare bones of night time support a handful of times in the final 6 months. I was crying out for help as he was suffering. If I could have held his hand and let him die quietly at a set time, it would have made the final moments so much better to cope with. We treat animals with more respect for a dignified death than we do people
