

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document.

This is something I care deeply about having helped nurse my Father as he neared the end of his life some 26 years ago, a memory still so vivid in my mind that it brings back the sadness of seeing him with tears in his eyes as he lost all dignity having to be washed, fed and nursed by his daughter. I remember he once asked me to end his suffering for him ... oh how I wish I'd had the strength to do so for his sake.

More recently we had to watch my brother struggle in the final stages of his life, in a distressing amount of pain, where he would then be knocked out by the medication which was administered to relieve the said pain, he was unable to communicate with anyone, he had no control over his bladder or bowel movements and had to be washed and changed by his loving family, a task I stress they did willingly but the pain in his eyes showed the anguish he was feeling throughout.

As he passed with his family by his side and we watched the pained expression leave his face it brought a comfort to know he was finally at peace.

I'm sorry if this is making little sense but I am so emotional as I write this.

These are human beings whom we love with all our heart, society deems it cruel to let an animal suffer, yet we find it acceptable to allow a fellow human being to go through the most horrendous and undignified suffering and that to me is heartbreaking.

I thank you for taking the time to read it and I hope you can support this bill for people like my Father and my Brother.
