

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document.

Questions marked with an asterisk (*) require an answer.

All responses must include a name and contact details. Q1. Which of the following best expresses your view of the proposed Bill?

Fully supportive

Please explain the reasons for your response.

Where illness severely impacts quality of life, people should have the right to choose a dignified end, the freedom to prevent prolonged suffering for themselves and close ones. We can live the life we choose, let's allow people to choose their death.

Q2. Do you think legislation is required, or are there other ways in which the Bill's aims could be achieved more effectively? Please explain the reasons for your response.

Legislation is required to prevent association of blame and guilt. It is essential to allow a clean death without suspicion of wrongdoing. It needs to be clear to protect the vulnerable.

Q3. Which of the following best expresses your view of the proposed process for assisted dying as set out at section 3.1 in the consultation document (Step 1 - Declaration, Step 2 - Reflection period, Step 3 - Prescribing/delivering)?

Fully supportive

Please explain the reasons for your response, including if you think there should be any additional measures, or if any of the existing proposed measures should be removed. In particular, we are keen to hear views on Step 2 - Reflection period, and the length of time that is most appropriate. Some time for reflection should be required, but this may be in proportion to the estimated time left in cases of terminal illness. Do not resuscitate orders should be a first step, then a note of interest made for assisted dying before it's finally signed off after a period of reflection. Time could be 20% , example 10 weeks reflection if one year is estimated before expected natural death.

Q4. Which of the following best expresses your views of the safeguards proposed in section 1.1 of the consultation document?

Please explain the reasons for your response. Safeguarding is necessary to protect vulnerable and assistants.

This could be managed in the same way as abortion, a referral to an assisted dying service in could be made to connect with specially trained health care professionals.
