

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document.

Q1. Which of the following best expresses your view of the proposed Bill?

It is time for Scotland to take a proactive approach to enabling those who have mental capacity and who have been diagnosed with a terminal illness to choose a Good and Graceful death.

Q2. Do you think legislation is required, or are there other ways in which the Bill's aims could be achieved more effectively? Please explain the reasons for your response.

I think legislation is required. This has to be a personal choice and therefore the rights of the individual making this decision require to be carefully and fully enshrined in law.

Fully supportive

Please explain the reasons for your response, including if you think there should be any additional measures, or if any of the existing proposed measures should be removed. In particular, we are keen to hear views on Step 2 - Reflection period, and the length of time that is most appropriate.
My only concern is the length of the reflection period. My personal experience would be that someone who is dying will not choose to end their life carelessly. I think that once the decision is made a great deal of reflection will have been applied before they have made their declaration. Therefore asking someone to wait a further 14 days seem unduly unkind.

Q4. Which of the following best expresses your views of the safeguards proposed in section 1.1 of the consultation document?

Please explain the reasons for your response.
The proposed safeguards appear to be fully explained and appear to be failsafe. However, as with most things in life until this 'theory' is applied in practice we will not know if this is indeed the correct approach or indeed if safeguards need to be reviewed.

No. I sincerely hope that the debate is open and honest. I am concerned that MP's have been given a 'free' vote. I know that our representative system does not allow them to canvas their constituents and that this vote will be based on their personal viewpoint. I don't think this is how this bill should be debated or resolved.
