

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document.

Questions marked with an asterisk (*) require an answer.

All responses must include a name and contact details. Q1. Which of the following best expresses your view of the proposed Bill?

Please explain the reasons for your response.

Caring for a loved one who is terminally ill is all consuming. Every minute is taken up by planning, organising and doing everything to ensure that your loved one is comfortable, pain free and able to enjoy some quality of life for the remainder of the time they have left. I could not have coped with that task if the option of assisted dying was available. I would have found it extremely stressful if my stepson, who had capacity, had been made aware of that choice. All resources should go into finding a cure for some of the worst terminal illnesses, MND being one of them, instead of finding ways that patients can be offered a way to commit suicide. Life is precious. No one should have a "bad" death. Ensuring that everyone has a "good" death is where the focus should be.

Q2. Do you think legislation is required, or are there other ways in which the Bill's aims could be achieved more effectively? Please explain the reasons for your response.

Doctors should be allowed to ensure that no patient is in pain or discomfort. There are presently DNR options available that patients can sign in advance. Consideration could be given to introducing an option for patients to choose in advance, that if they were at the last stages of a terminal illness and in pain, they could choose to have their pain relieved even if the consequence was that their life may end sooner.
