

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document.

I am fully supportive of assisted dying, having watched my own mother basically starve to death, I would not wish this on anyone. It would have the safeguards of two doctors and only be for the use of people with terminal illnesses. It's not fair to let people die in this way, when it could be a quick and dignified death. It is not only traumatic for the person who is terminally ill, it is traumatic for their loved ones having to witness a horrible death. I know my mother would have chosen to die quickly and at her choosing. She just wanted to die in the end as the pain was just too much and she should have had that choice. It was a matter of weeks before the end that could have changed so much for her.
