

# Assisted Dying for Terminally Ill Adults (Scotland) Bill

## Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document.

The reflection period seems reasonable. I do however have concerns that the requirement for the person to administer the end of life medication will preclude those who are suffering from mobility conditions who are likely to lose their mobility long before they may wish to end their life with dignity. Could a particular exception with safeguards be included for those who are mentally capable to take the decision but are not physically able?

**Please explain the reasons for your response.**

I feel almost all the safeguards are fair and justified. As per my previous response, I am concerned at the potential limitations that would be placed on those with terminal conditions that attack their mobility to access an assisted end of life where they no longer have the physical function to administer the medication themselves.

My view would be that any healthcare professional should have the right to ask not to participate. This should be accompanied however with some means to allow persons to access this assistance even if local health professionals do not wish to participate (I am thinking of rural areas with only one dispensary and few doctors). For example, there could be a referral process via the local NHS board.
