

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document.

Naturally there must be robust regulation surrounding the suggestions, but in principle a person should be allowed to make the decision to end their life in circumstances where their quality of life has deteriorated significantly due to a terminal illness.

Unsure if having a general HCP measure and prepare the drugs to be used by the terminally ill individual is wise. Possibly some form of additional training/certification/check to ensure that HCPs are not forced to be involved in something that they may disagree with for whatever reason.

In terms of the duration, I believe that the duration of time that the individual has lived with a terminal condition should be taken into account. Recently diagnosed terminal conditions should afford a longer reflection time period given how traumatic and upsetting it can be post diagnosis.
