

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document.

There is a need, in fact, to establish policy, procedures, protocols and guidance as a coherent and regulated basis for the Assisted Dying of the terminally ill.

No. At the moment there is in reality ad hoc medical and nursing practices - these are not clear or consistent or open to scrutiny because there is no assisted dying legislation despite the everyday practices at home and in hospices.
