

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document.

The safeguards are robust, without putting a terminally ill person through more trauma by making the safeguarding so daunting that the person could not cope with the process

I think that a new body should be tasked with safeguarding, specially trained doctors and HCP,s should take referrals from a patient's GP and then two doctors from that body should make an assessment of each case before making a final recommendation. Prognosis, likelihood of suffering and mental state should be taken into consideration.

Q6. Please provide comment on how a conscientious objection (or other avenue to ensure voluntary participation by healthcare professionals) might best be facilitated.

HCP must always have the right to conscientious objection, but cannot prevent the patient seeking assistance from another health professional.
