

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document.

Q1. Which of the following best expresses your view of the proposed Bill?

Fully supportive

Please explain the reasons for your response.

My grandpa died of bladder cancer which had spread to his lungs, liver and most parts of his body. He lingered on for months and parts of his body became deformed by sore lumps - the worst being on his forehead. He was almost blind as well as almost deaf. I had to assist him with personal care including assistance to go to the toilet. On these occasions, blood would literally explode from his penis and cover the bathroom causing him pain and distress. He also had blood coming from his bowels and coughed up large quantities of blood. The lump on his head was what had caused him the most distress as it was so agonising for him. He was always a dignified man who was very intelligent, but in the last months of his life, he continued to be treated with antibiotics which prolonged his life and his pain. He became delirious for quite some time and he did not know his own grandson which was heartbreaking. He was in so much pain and bleeding from almost every orifice and I don't believe his death should have been prolonged by constant courses of antibiotics. He was in his 90's and his body was ravaged with cancer, he should have been allowed to die with dignity.
