

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document.

I believe, if fully able to provide consent, every person should be allowed to decide to end their life in a dignified manner rather than live, possibly for many years, in pain, or in need of constant personal care.

I think legislation is required. If a person makes their wishes for assisted dying known, and their family helped them with this, without the proper legislation in place the family could then be facing legal action at a time when they need space to grieve.

Fully supportive

I think a reflection period is important. This is an emotive issue and each individual should be allowed time to reflect on their decision. I think the reflection period should be around 7-10 days.
