

Assisted Dying for Terminally Ill Adults (Scotland) Bill

Introduction

A proposal for a Bill to enable competent adults who are terminally ill to be provided at their request with assistance to end their life.

The consultation runs from 23 September 2021 to 22 December 2021.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document.

Please explain the reasons for your response.

Palliative care is a time when patients and their family/support network are facing the most sensitive and emotional period of their lives. This period is often made more intensive and traumatic for all parties the longer drawn out it becomes, while treatments aimed at comfort become less effective. There is no compassion or dignity in enforcement of life against a person's wishes, when who they are and were as a person becomes lost to unnecessary suffering while relatives watch their loved one become unrecognisable. An image which will linger and be far from the deceased person's true self and wishes of how to be remembered.

No matter how respectful and dignified we try to be ourselves in life, they are options taken from us whilst we are at our most vulnerable. I don't believe there is much that can be done when the onset of such illness is sudden and unexpected, but when there is opportunity to ask and hence respectfully adhere to how they wish to handle things themselves, it's unconscionable not to give them that last and truly final choice.
